

No. 5 UNIFORM DIRECTED TRUST ACT

The The Uniform Directed Trust Act provides statutory authority for a trust to name a person who can direct the trustee to make certain changes to irrevocable trusts. We refer to this person as a "trust protector" or a "trust advisor." This trust protector can be given the power to direct the trustee in investing, managing or distributing trust property or other matters. A trust protector can also be given the power to make changes to irrevocable trusts that otherwise could only be made by a court of law (which, as we all know, can be time-consuming and expensive). The Act allows irrevocable trusts to be updated for law and tax changes, to correct errors and ambiguities, and to make the trustmaker's wishes effective – all without court involvement. (Actually, we have already been including provisions for a trust protector in our trusts. But the powers given haven't been as broad as the new Act allows. Plus, now we have clear Montana statutory authority for doing so.)

NO. 6 UNIFORM TRUST DECANTING ACT

The Uniform Trust Decanting Act allows us to "decant" an irrevocable trust into another irrevocable trust that has more favorable terms – without court involvement. Yes, the Act contains guidelines and limitations to make sure that the trustmaker's wishes are followed. The law allows a family to update a trust when changed circumstances make it clear that, if the Trustmaker were available to make the changes, he or she would do so. Again, without the time and expense of court involvement.
